draining/retention of water for rice cultivation. This ditch exhibited pooled stagnant water at the surface, a bed, and banks, but did not feature characteristics of flow. Within the ditch was ponded water and an undisturbed accumulation of leaf litter within a deciduous palustrine wetland, leading the conclusion that this feature typically acts a means of retention, rather than flow, during normal climatic conditions. While this feature was not deemed as jurisdictional due to the lack of flow, the ditching was within the wetland portion of the site..

Summarize rationale supporting determination: **The Great Pee Dee River is a major river system. According to the Corps' 1977 Charleston District Report 11, Great Pee Dee River Basin, 1977 Navigability Study, the Great Pee Dee River is navigable historically and presently up to River Mile (RM) 165 for regulatory purposes, tidally influenced to RM 33, and has a recommended limit of navigation up to RM 188.2. This project is located ~0.45 miles inland at RM 12 and is hydrologically connected to a tidally influenced inlet via ~2450 feet of excavated ditching.**

##### 2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": **This project is located ~0.45 miles inland of the Great Pee Dee River at approximately RM 12. The on-site wetlands are hydrologically connected to a tidally influenced inlet of the Great Pee Dee River via ~2450 feet of excavated ditching. The ditching begins within the wetlands, continues off-site through a roadside ditch adjacent to County Road S-22-376, crosses under the roadway via a culvert, then continues to the inlet through an excavated canal on an adjacent private landowners property.**

#### B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

On January 16, 2019, Corps personnel and the applicant's consultant performed a site visit to verify the presence, location, and jurisdiction of on-site aquatic resources. On-site 2.63 acres of wetlands were identified / verified; the location was per the depiction provided during the initial submission package, within the northern part of the site. Within the wetlands, we found saturated hydric soil from surface to approximately 18 inches, as well as hydric plants throughout the entire site.

Within the wetland area a ~560 linear foot excavated ditch was identified. This ditch was historically used for draining/retention of water for rice cultivation. This ditch exhibited pooled stagnant water at the surface, a bed, and banks, but did not feature characteristics of flow. Within the ditch was ponded water and an undisturbed accumulation of leaf litter within a deciduous palustrine wetland, leading the conclusion that this feature typically acts a means of retention, rather than flow, during normal climatic conditions. While this feature was not deemed as jurisdictional due to the lack of flow, the ditching was within the wetland portion of the site.

This project is located ~0.45 miles inland of the Great Pee Dee River at approximately RM 12. The on-site wetlands are hydrologically connected to a tidally influenced inlet of the Great Pee Dee River via ~2450 feet of excavated ditching. The ditching begins within the wetlands, continues off-site through a roadside ditch adjacent to County Road S-22-376, crosses under the roadway via a culvert, then continues to the inlet through an excavated canal on an adjacent private landowners property. The Great Pee Dee River is a major river system. According to the Corps' 1977 Charleston District Report 11, Great Pee Dee River Basin, 1977 Navigability Study, the Great Pee Dee River is navigable historically and presently up to River Mile (RM) 165 for regulatory purposes, tidally influenced to RM 33, and has a recommended limit of navigation up to RM 188.2.

Waverly Mills Quadrangle USGS topographic map depicts a forested site with no significant elevation change nor any aquatic (blue line) features. Georgetown soil survey, Page 32, depicts two soils on-site, including Bladen loam and Yemassee loamy fine sand. All on-site soils are listed in the 2016 South Carolina Hydric Soils list as hydric. National Wetland Inventory maps depict 2.82 acres of the central - northern portion of the site as palustrine broad-leaved deciduously forested wetland that is seasonally saturated (PFO1B). The remaining 2.26 acres of the site is depicted as upland planted pines (U42P).

This site was assessed per the provided site maps and on a single-basis form.
