wetland complex that spans to the south/southwest and eventually becomes part of the tidally influenced wetlands of the Savannah River, an (a)(1) Traditional Navigable Water (TNW). The off-site Monkey John Swamp is divided by multiple artificial structures (roads). However, according to best available aerial imagery, culverts within the artificial structures that are
active at least once in a typical year provide a direct
hydrologic connection.

- B. Typical year assessment(s): Antecedent Precipitation Tool (APT) data for typical year determination were calculated for the date of a best available aerial image via Google Earth Pro©, July 12, 2020. The APT data were calculated to determine if culverts dividing the off-site Monkey John Swamp provide direct hydrologic connections during typical year conditions. According to output from the APT, conditions for this date exhibited "Normal" conditions with a product of 13.
- C. Additional comments to support AJD: According to best available imagery via Google Earth Pro© on July 12, 2020, water is visible on both sides of culverts within roads that are dividing the off-site Monkey John Swamp. According to the aforementioned APT data the conditions on this date were indicative of normal conditions. Therefore, this office has determined that the culverts are providing a direct hydrologic connection at least once in a typical year.
