Explain: **Three wetlands [NJW-A (0.44 ac.), NJW-B (0.65 ac.), NJW-C (0.53 ac.)] in the review area were determined to be isolated (non-jurisdictional). These three wetlands were previously determined to be jurisdictional under SAC-2009-01328, Jurisdictional Determination letter dated September 16, 2010, via a man-made, non-jurisdictional ditch. However, after the issuance of our Jurisdictional Determination letter dated September 16, 2010, the landowner filled**

in the non-jurisdictional ditch causing the three wetlands to become isolated. The wetlands were then determined to be non-jurisdictional under the same SAC#, Jurisdictional Determination letter dated February 23, 2017. After reviewing, aerial photographs, topo maps, soil survey information, and NWI maps, it was determined that there has been no development on the property or any landscape changes that could potentially create a hydrologic connection from the wetlands to any other waters of the U.S. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. The non-jurisdictional wetlands show no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the non-jurisdictional wetlands and waters of the U.S. Because of the lack of discernable outfall, topography grades, and lack of evidence of a chemical or biological connection to other waters of the US, these wetlands were determined to be isolated and non-jurisdictional.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Three wetlands [NJW-A (0.44 ac.), NJW-B (0.65 ac.), NJW-C (0.53 ac.)] in the review area were determined to be isolated (non-jurisdictional). These three wetlands were previously determined to be jurisdictional under SAC-2009-01328, Jurisdictional Determination letter dated September 16, 2010, via a man-made, non-jurisdictional ditch. However, after the issuance of our Jurisdictional Determination letter dated September 16, 2010, the landowner filled in the non-jurisdictional ditch causing the three wetlands to become isolated. The wetlands were then determined to be non-jurisdictional under the same SAC#, Jurisdictional Determination letter dated February 23, 2017. After reviewing, aerial photographs, topo maps, soil survey information, and NWI maps, it was determined that there has been no development on the property or any landscape changes that could potentially create a hydrologic connection from the wetlands to any other waters of the U.S. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. The non-jurisdictional wetlands show no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the non-jurisdictional wetlands and waters of the U.S. Because of the lack of discernable outfall, topography grades, and lack of evidence of a chemical or biological connection to other waters of the US, these wetlands were determined to be isolated and non-jurisdictional.
