Summarize overall biological, chemical and physical functions being performed: **The wetland in the review area is connected to Reeder Point Branch through off-site pipes. This wetland and Reeder Point Branch are performing a variety of functions that relate to the biological, chemical, and physical integrity of the TNW. This wetland provides breeding grounds for aquatic species and habitat for wildlife in the area. This wetland helps to filter pollutants from the nearby businesses and roads before they travel downstream to the TNW. This wetland provides flood storage in times of heavy rain and during the wetter months..**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
