C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

perennial under a previous jurisdictional determination (2007-02225-3JC) documented in a letter dated October 29, 2008. The tributary was assessed for this determination at a public access point located on McDowell Shortcut road. At this location the tributary was observed flowing water under drought conditions, as well as defined bed and banks, accumulated trash on the banks and a well defined OHWM. Furthermore, biological indicators of perennial flow were observed such as fish and other aquatic life. A review of aerial photos depict a signature of a defined linear channel with water, USGS topographic map depicts a symbol which typically represents a tributary with a flow regime of intermittent. Site visits performed throughout Horry County have revealed that USGS topographic maps typically underestimate the flow regimes in this portion of the coastal plain. This offsite tributary is located in the headwaters of Collins Creek which is the TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area had a previous determination dated October 29, 2008 (SAC 2007-02225-3JC) which expired October 29, 2013. The wetland documented as jurisdictional under that determination is the same delineated wetland documented under this determination. The project area presently consists of cleared/grassed uplands and a small forested wetland located in the northeast corner of the project area. The onsite wetland was determined to be adjacent to an offsite tributary that drains directly into Collins Creek; a TNW. The project area is comprised of 9.27 acres of uplands and 0.21 acres of freshwater wetlands. Onsite there are two (2) upland excavated ditches that were determined to drain only uplands and therefore determined to be non-jurisdictional features.
