**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A site visit was conducted on June 2, 2015. A small jurisdictional pond/impoundment was observed on the western side of the property. It appeared that the pond/impoundment was excavated out of uplands. However, the rising tide was observed flowing into the pond/impoundment via 36" R.C. pipe. The pond/impoundment is located across Hwy 17 from a tidal marsh that leads to the Atlantic Ocean. Tide gauges for the area (NOAA tide gauge attached) depicts high tide at approximately 10:33 am. The site visit was conducted at 9:30 am during the rising tide.
