**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This site is a 14.36 acre portion of a larger tract that was previously determined to be void of waters of the United States, including wetlands. The previous JD letter was issued under SAC# 84-2003-1619 (Letter dated January 26, 2004). After researching the best available information, including aerial photographs, topographic maps, soil survey information, and NWI maps, it was determined that the surrounding landscape (i.e. development) has remained essentially the same since 2004. Therefore, the Corps determined that the soils, vegetation, and hydrology information submitted on the consultants data sheets on May 7, 2015 are a true representation of the current site conditions. Therefore, the Corps did not conduct another site visit for this determination. Furthermore, hydric soils (i.e. Leon) are mapped on the site. However, according to previous determinations and current information submitted by the consultant, the areas mapped as a Leon soil series more closely represent the adjacent mapped Kenansville soil series. In addition, topographic maps do not depict any wetlands or tributaries on the site.
