C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 17.06 acre project area that contains 1.23 acres of Jurisdictional freshwater wetlands that were determined to flow into Buck Creek, a perennial RPW, via a contiguous wetland run that continues off site to the south and abuts Buck Creek to the west. These wetlands are depicted as palustrine forest on NWI maps and as being comprised of 100 % hydric soils on Horry County soil survey maps. Review of USGS topographic maps reveal peaked topo lines from the wetland on site to the larger wetland system south of the site which indicates a naturally low lying drainage area. Buck Creek Flows uninterrupted into the Waccamaw River, a TNW .
