One upland excavated ditch is located along the western project boundary. This feature is man-made, drains only uplands and was determined to be a non-jurisdictional feature.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: **This form addresses a 0.653 acre forested residential lot that contains 0.342 acres of uplands and approximately 0.311 acres of an upland excavated non-jurisdictional pond. This site was determined to consist of uplands in Approved JD 81-95-1054 issued on July 18, 1995 which included a site visit. Data sheets and site photos submitted by the agent reveal that the site does not contain soils that meet any hydric soil criteria and that the site lacks sufficient indicators of hydrology and therefore does not meet the required criteria set forth in the 1987 delineation manual for identification of a wetland. In addition, one upland excavated ditch is located along the western project boundary. This feature is man-made, drains only uplands and was determined to be a non-jurisdictional feature.**
