C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

climatic conditions. The stream geomorphic indicators of perennial flow was a channel within the bed and banks which had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel such as leaves being continuously washed downstream and water flowing under drought conditions. In addition, other hydrologic indicators observed were an even distribution of substrates in the stream channel. A review of aerial photos, topographic maps, Horry County Soil Survey, and Horry County LIDAR revealed that the tributary was determined to be an RPW with perennial flow. .

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of jurisdiction of wetlands were established by 1987 Delineation Manual. The onsite wetlands (Wetland 1 / 0.39 acres + Wetland 2 / 1.49 = 1.88) comprises a portion of a natural drainage basin of the Waccamaw River. Wetland system abutts the OHWM of the perennial tributary that serves as the eastern site boundary. Flow of the tributary was observed and determined to be at least 90% of the year under normal climatic conditions. The stream geomorphic indicators of perennial flow was a channel within the bed and banks which had a firm sandy bottom clear of vegetation and debris, sediment bars located adjacent to the channel which is evidence of perennial flow as well as hydrologic indicators observed within the channel such as leaves being continuously washed downstream and water flowing under drought conditions. In addition, other hydrologic indicators observed were an even distribution of substrates in the stream channel. A review of aerial photos, topographic maps, Horry County Soil Survey, and Horry County LIDAR revealed that the tributary was determined to be an RPW with perennial flow.

Also located onsite are three upland excavated non-jurisdictional ditches and a single upland excavated non-jurisdictional pond. These features did not exhibit any jurisdictional features and did not connect to any other aquatic resources.
