Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The review area is a portion of a larger tract that was previously delineated and a JD was issued under SAC# 2012-00362-3B letter dated April 2, 2015. There is a small area within the review area that was previously determined to be wetlands; however, after further research and additional site visits, this area was determined to be uplands. During the site visit on June 19, 2017, it was determined that the area in question did not exhibit hydric soils or hydrology. More than 30% uncoated sand grains were observed in the upper 6" of the soil profile and no indicators of hydrology were present. The soil exhibited no saturation and no oxidized rhizospheres along living root channels. The recent maintenance of a large onsite drainage ditch and the mining operation directly adjacent to the south could have contributed to the lack of hydrology in this area.

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). ## C. SIGNIFICANT NEXUS DETERMINATION

1

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
