**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of jurisdiciton determined by the OHWM. Tributary 1A / 316' linear feet + Tributary 1B 228' linear feet = 544' total length with an average width of 9' for each jurisdictional features located onsite. The tributary located onsite was determined to flow at least 90% of the year under normal climatic conditions. A review of aerial photos, topographic maps, Horry County Soil Survey, Horry County LIDAR data, and Horry County Drainage Canal Study revealed that the tributary was determined to be an RPW with perennial flow. **B. ADDITIONAL COMMENTS TO SUPPORT JD:** Two wetlands that were assessed in the field were determined to be isolated (non-jurisdictional). From a review of Horry County Soil Survey, NWI, LIDAR data, no surface or shallow subsurface connection to another water of the U.S. was evident. All water contained within the wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict wetland symbols where the isolated wetlands were observed in the field. No linear features (i.e. blue lines) were observed in the field or depicted on the topographic maps in the vicinity of the isolated wetlands.

Additionally, located onsite was depression / swale feature that did not exhibit wetland parameters and was determined to be a non-jurisdictional feature.
