of the CWA, nor Section 10 of the RHA. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "water-filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S. This feature is determined to be a non-jurisdictional, upland excavated borrow pit, as it was wholly excavated in upland, currently does not support vegetation communities and is considered to be open water. For these reasons, the borrow pond was determined to be non-jurisdictional and not regulated by Section 404 of the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

bed and bank can be observed from a 2017 Google Earth aerial image. In addition, it appears that this tributary drains an approximately 3 square mile area, obtaining hydrological inputs from surrounding wetlands within the approximate drainage area, as well as from upland runoff also in the drainage area. The unnamed tributary flows into another unnamed tributary, which then flows into McChune Branch, another offsite perennial tributary. McChune Branch flows for 5 miles, where it then discharges into Goose Creek Reservoir, a TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland listed in Section I.B.1.b meets the three parameters of a wetland. The wetland feature listed in Section I.B.1.b above is directly abutting an unnamed perennial tributary described in Section III.D.2. The unnamed perennial tributary appears to exhibit perennial flow, as a defined flow channel and bed and bank can be observed from a 2017 Google Earth aerial image. In addition, it appears that this tributary drains an approximately 3 square mile area, obtaining hydrological inputs from surrounding wetlands within the approximate drainage area, as well as from upland runoff also in the drainage area. Therefore, it was determined that the wetland listed above in Section I.B.1.b is jurisdictional under Section 404 of the CWA.
