consists of one (1) jurisdictional wetland which is assessed on JD Form 2 of 2. The 14 wetlands were observed in the field by the consultant and the Corps during a field visit on May 25, 2018. The wetlands were determined to be surrounded on all sides by non-hydric soils and/or hydric soils with no indicators of hydrology. The site is a 235 acre planted pine stand. No ditches, swales, or tributaries were observed in or near the wetlands to convey water to downstream tributaries. The topographic map depicts a solid blue line (i.e. linear conveyance) towards the southern portion of the property in the vicinity of Wetlands 14 and 15. However, observations in the field revealed that the blue line depicted on the topo map does not exist on the property. All water contained within these wetlands is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, these wetlands were determined to be isolated non-jurisdictional and not connected to any other waters of the U.S. The onsite isolated wetlands were also determined to have NO substantial nexus to interstate (or foreign) commerce.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
