- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **the project area contains several non-jurisdictional ditches that are depicted on the referenced plat dated June 13, 2018. These features were previously determined under SAC 2013-00411-3B to have been excavated from within uplands and draining only uplands. In addition, SAC 2013-00411-3B identified several potential wetland areas that indicated hydric soils, and hydrophytic vegetation however lacked hydrology and/or indicators of hydrology. A review of the submitted data sheets in the submittal dated June 11, 2018,, reveals that hydric soils and hydrophytic vegetation exist however, the hydrology parameter is not met.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A site visit was not warranted after review of available desk top resources which included all resources listed in Section IV. Part A above and the two previous Jurisdictional Determinations where site visits were performed. The following is was documented under SAC 2013-00441 in regards to potential wetlands and non-jurisdictional ditches: "Several ditches were observed in the field and determined to be non-jurisdictional. The ditches were located entirely in uplands and did not exhibit any geomorphic characteristics of water flow. Also, there were several areas on the tract depicted on the plat as "TMS# 117-00-02-419" that exhibited hydric soils and hydrophitic vegetation. However, there were no hydrology indicators observed during the site visit which was during a time of above normal rainfall. These areas potentially could have been affected by the numerous ditches found onsite. These areas were determined to be uplands". The has been determined to be comprised entirely of uplands.
