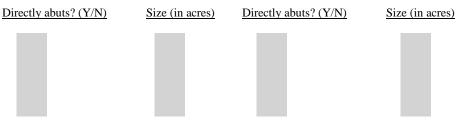

# C. SIGNIFICANT NEXUS DETERMINATION

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses a 2.36 acre tract that contains 0.55 acres of jurisdictional freshwater waters (0.07 AC. Wetlands and 0.48 AC TNW). Limits of jurisdiction for wetlands were established by the parameters set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement. Wetlands are separated geomorphically from adjacent WOUS by uplands areas that were the campus grounds of the defunct Grainger Generating Station (higher in elevation). Onsite wetlands continue offsite and discharge directly into the Waccamaw River.

Located onsite is a portion of the Ash Pond #1 used by the defunct Graniger Generating Station that does not connect to any other WOUS and not considered an impoundment of WOUS.

This site is assessed on a single basis form.
