C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The subject property is 2.78 acres and consists of 0.24 acres of isolated non-jurisdictional wetlands. There are three previous JD's (SAC# 80-2003-0468 Letter dated 4/15/2003, SAC# 2003-31441-3B Letter dated 1/8/2009, SAC#2003-31441 letter dated May 6, 2014) on this site which also determined the wetland to be isolated. A portion of the wetland has been filled in accordance with the previous JD's. The onsite wetland meets the parameters that define a wetland outlined in the 1987 Wetland Delineation Manual; however, the wetland was determined NOT to be adjacent to any waters of the U.S. (WOUS). The entire perimeter of the wetland was observed during previous determinations site visits and was determined to be completely surrounded by non-hydric soils and surface or shallow subsurface connections to any water of the U.S. were not evident or could be found after review of aerial photography, soil survey information, NWI maps, and topographic maps. All water located within or draining toward the wetland has no discernible or traceable outfall or connection to any WOUS. Chemically, the wetland does not affect any WOUS in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of the wetland and its relation to any WOUS is such that water in the wetland is retained and eventually percolates through the soil to groundwater only, to an unknown depth. Biologically, the wetland is not essential in providing organic carbons in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical, physical, or biological connection, this wetland system has been determined to be isolated, non-jurisdictional. The onsite wetland was also determined to have NO substantial nexus to interstate (or foreign) commerce.
