- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The project area contains an upland excavated stormwater pond, an upland excavated stormwater ditch and a potential wetland area that lacked all three parameters that define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual and Regional Supplement. The non-jurisdictional stormwater pond was previously excavated from within uplands as determined under the previous Jurisdictional Determination documented under SAC-2016-00514. The upland excavated stormwater ditch was previously determined to be located within uplands and not a waters of the US. The potential wetland area is documented in the submittal dated July 9, 2019, submitted by S&ME on data forms 1 & 2, dated July 3, 2019, as lacking the Hydrology parameter. Rainfall data collected under the Antecedent Rainfall Calculator for the previous three months indicates the project site is under normal rainfall.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area was determined to be void of any jurisdictional aquatic resources by review of all available desktop resources and the information provided in the submittal dated July 9, 2019, submitted by S&ME. A review of rainfall data collected under the NOAA Antecedent Rainfall Calculator indicates normal rainfall for the previous three months prior to the data collected and outlined in the submitted data sheets (1&2) dated July 3, 2019. The data sheets submitted and prepared by S&ME indicate the absence of Hydrology and therefore not meeting the three parameters that define a wetland as defined in the Corps' 1987 Wetland Delineation Manual. A review of google earth photos dated 2016 and 2019 indicate increased development adjacent and within the project boundaries also supporting the lack of hydrology. The project area is currently surrounded by increased development which has been steadily increasing since 2016 (Single Family housing development, public access roads, stormwater features- ponds & ditches). Based on the available desktop resources reviewed (see Section IV.A above), the project area has been determined to be comprised entirely of uplands.
