off-site into a large wetland area abutting the Pocatoligo River. Within and surrounding the ditching is a contiguous wetland area that has a direct connection to the off-site wetlands abutting the Pocatoligo River. The on-site ditching is excavated within the boundaries of the on-site wetland, but did not exhibit the characteristics of flow of a jurisdictional tributary/water.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other information (please specify): The site consists of an agricultural field maintained as such since at least 1994, per Google Earth aerial imagery (1994-2017). According to the applicant and the applicant's consultant, the site does not have an active NRCS Jurisdictional Determination or Prior Converted Cropland documentation. Within the site is a ~920 ft. long excavated ditch that begins in the western portion of the site and terminates off-site into a large wetland area abutting the Pocotaligo River. Within and surrounding the ditching is a contiguous wetland area that has a direct connection to the off-site wetlands abutting the Pocotaligo River. The on-site ditching is excavated within the boundaries of the on-site wetland, but did not exhibit the characteristics of flow of a jurisdictional tributary/water.

On November 16, 2018, the Corps preformed a site visit and found the following: "The site consists of ~15 acres of agricultural fields with an excavated drainage ditch running through the middle of the site. Wetlands were identified adjacent to and east of the drainage ditch within the project site. Key identifiers for the wetlands included hydric soils with thick dark surfaces, hydrophytic plants, and wetland hydrology, including subsurface saturation to ~10 inches and surface inundation visible on aerial imagery for multiple years in the past."

The updated delineation map, "**CLARENDON HEALTH / LONG TERM CARE / LOCATED IN THE TOWN OF MANNING / CLARENDON COUNTY, SC**", and dated: June 12, 2019, is an accurate depiction of what the Corps identified on-site in November 2018.

Of the on-site soil types Rains sandy loam and Lynchburg loamy sand are both listed as hydric on the 2016 South Carolina Hydric Soils list. NWI Maps depict the site as cropland/pasture (U21).

The project site was assessed on a single basis form per the provided site map.
