This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: The on-site seasonal RPW is performing a variety of functions related to the biological, chemical, and physical integrity of the downstream TNW. The seasonal RPW is located less than one mile from the perennial RPW. It is located in an area that is surrounded by industrial/commercial buildings and roads. This seasonal RPW provides breeding grounds for aquatic species and habitat for wildlife in the area. It also helps to filter pollutants and remove excess nutrients in runoff from the surrounding uplands. This tributary also performs flow maintenance functions by storing water during heavy rains and the wetter months. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the downstream TNW, it has been determined that there is a significant nexus between the relevant reach of the tributary to the downstream TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Aquatic resources documented on this form include 4 RPWs (3 perennial RPWs and 1 seasonal RPW). According to guidance provided, RPWs are jurisdictional, however, the significant nexus findings are included for the seasonal RPW as required by Rapanos Guidance. Therefore, the waters documented on this form are jurisdictional under the Clean Water Act and considered waters of the U.S.
