- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

Historically the project limits for this project may have contained aquatic features. This site has been altered by earthmoving activities in the past. As documented in the Memorandum for File for this project, dated June 24, 2019, historically mapped NWI wetlands (or ponds) were present in June 4, 2006 aerial photography. In 2008, SCDHEC issued a NPDES authorization to construct a stormwater basin on this site. It appears that site grading occurred after that time and in the next available aerial photograph of this site; (June 9, 2011) the previous ponds were no longer present (drained & graded) and the stormwater basin had been constructed and was located on the southern end of the project area. It is possible that this activity met the terms and conditions of NWP 43, Stormwater Management Facilities, which allows the construction of a stormwater detention basin.

Currently there are no jurisdictional waters present on this site. This is due to previous site development/earthwork that occurred within the project limits that have resulted in creating uplands, without any jurisdictional characteristics. In addition, the area utilized for the construction, use and later close out of the stormwater detention basin authorized by SCDHEC under an NPDES permit; is not jurisdictional under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The features documented on this form include documentation of historical site development including grading and the construction of a NPDES authorized stormwater basin. Current conditions do not include aquatic features and this site contains no areas that have jurisdictional characteristics.
