Summarize rationale supporting conclusion that wetland is "adjacent": **On-site wetlands are a portion of a contiguous wetland ecosystem that continues off-site and abuts a 2,000 LF unnamed drainage feature with a direct hydrologic connection to Simpson Creek, a relatively permanent water (RPW). Simpson Creek flows into the Waccamaw River 11.75 miles downstream at the Waccamaw's RM ~85.**

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

In detail: immediately south of the project area, oriented northeast/southwest, is Heritage Road, which has hydrologic cross flow from the north to south side of Heritage Road via multiple culverts. Abutting the south side of Heritage Road perpendicularly, directly across from the project area, is a ~2,000 LF manmade conveyance system which drains into Simpsons Creek (RPW). A contiguous wetland system from the project area to Simpson Creek (RPW), along the manmade conveyance, is readily identifiable on recent Google Earth imagery and NWI maps, the only physical break in this wetland system is Heritage Road. However, there is a hydrological connection across (under) Heritage Road via roadside ditching and culverts. The ditching, and subsequent path of flow, supporting this hydrologic connection is identifiable on LiDAR and all available recent aerial images.**

- Other information (please specify): **LiDAR digital elevation model (DEM) depicts a generally uniform elevation site with no significant drainage features within the site. Abutting the south side of Heritage Road perpendicularly is a ~2,000 LF manmade conveyance leading to an unnamed impoundment (pond) which drains into Simpsons Creek, the path of flow can be clearly seen on LiDAR imagery south of the site. The complete 1,556 acre drainage basin which leads to Simpson Creek is readily identifiable on LiDAR using elevation contours (sheet flow) and drainage features (ditching).**

The site was assessed by the Corps on May 15, 2019, for a possible unauthorized activity, while on-site wetlands were found broadly throughout the southern-to-mid portion of the tract, with the exception of the southwest corner, abutting Heritage Road.

On-site wetlands are a portion of a large contiguous swath of wetlands that continue off-site to the south, abutting a manmade unnamed drainage feature, then continuing on to abut and drain into Simpson Creek (RPW). In detail: immediately south of the project area, oriented northeast/southwest, is Heritage Road, which has hydrologic cross flow from the north to south side of Heritage Road via multiple culverts. Abutting the south side of Heritage Road perpendicularly, directly across from the project area, is a ~2,000 LF manmade conveyance system which drains into Simpsons Creek (RPW). A contiguous wetland system from the project area to Simpson Creek (RPW), along the manmade conveyance, is readily identifiable on recent Google Earth imagery and NWI maps, the only physical break in this wetland system is Heritage Road. However, there is a hydrological connection across (under) Heritage Road via roadside ditching and culverts. The ditching, and subsequent path of flow, supporting this hydrologic connection is identifiable on LiDAR and all available recent aerial images.

Project site's wetlands adjacency to jurisdictional waters: On-site wetlands are a portion of a contiguous wetland ecosystem that continues off-site and abuts a 2,000 LF unnamed drainage feature with a direct hydrologic connection to Simpson Creek, a relatively permanent water (RPW). Simpson Creek flows into the Waccamaw River 11.75 miles downstream at the Waccamaw's RM ~85. The Waccamaw River is a current and historically traditionally navigable river that is subject to the ebb and flow of the tide to River Mile (RM) ~60. Waccamaw River's limit of practical navigation is at RM ~128. Waccamaw River's present/historical navigation limit is at RM ~140.

Simpson Creek's relative permanence discussion: Simpson Creek is a ~11.75 mile long relatively permanent water under the jurisdiction of the Corps of Engineers due to multiple factors: 1) a direct hydrological surface connect with a traditionally navigable water, the Waccamaw River; 2) indicators of historical permanence to include a maintained channelized tributary for human development in the region; and 3), multiple physical indicators, including: a visible OHMW, a bed and banks, sinuosity of flow, a continuous significant flow of water, and an abundant swath vegetation the water body supports, including abutting wetlands throughout its range.

Data source information: 10 digit HUC: 0304020406 (Lake Swamp - Little Pee Dee River). Loris quadrangle depicts the site as forested with wetland symbology throughout the entire site. Horry County soil survey, sheet 28, depicts three soils within the project area, including: Pocomoke fine sandy loam, Echaw sand, and Osier loamy sand. All soils within the project site are listed on the 2017 South Carolina hydric soils list as hydric for Horry County. National wetlands inventory map depicts the site in its entirety as a mix of needle-leaved palustrine forested wetlands (PFO4Bd) and needle-leaved palustrine evergreen scrub shrub wetlands (PSS4Bd), both of which are seasonally saturated and partly drained/ditched. LiDAR digital elevation model (DEM) depicts a generally uniform elevation site with no significant drainage features within the site. Abutting the south side of Heritage Road perpendicularly is a ~2,000 LF manmade conveyance leading to an unnamed impoundment (pond) which drains into Simpsons Creek, the path of flow can be clearly seen on LiDAR imagery south of the site. The complete 1,556 acre drainage basin which leads to Simpson Creek is readily identifiable on LiDAR using elevation contours (sheet flow) and drainage features (ditching).

Within the project site are 18.67 acres of jurisdiction wetlands. This site was assessed on a single-basis form per the provided site maps and information.
