- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: According to the topographic map, a blue line named Powder Horn Branch intersects this project boundary; however, according to the aeriels, soil survey, NWIs and a previous determination for the property located north of this site, there is no tributary on site. The aeriels depict this site as predominately cleared with no tributary or other linear feature present. The soil survey maps this entire site as Rains, and the NWIs map the southeastern property corner as Palustrine forested wetlands. The agent submitted a data point near the southeastern property corner, and no hydric soils or indicators of hydrology were observed at this location. A JD conducted north of the project site (SAC 2007-02119, letter dated October 1, 2007) determined that the site contained uplands with no linear features present. Based on this information, the site was determined to consist entirely of uplands .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
