C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The seasonal tributary labeled “Other Jurisdictional WOUS 1” is located in an area where previous delineations documented a swale or other non-jurisdictional drainage feature. Since previous JDs, the surrounding area has urbanized and impervious surface increased greatly. Additionally, a retention pond was constructed at the top of this feature and outfalls into the feature. This funneling of stormwater into what was previously identified as only a drainage feature has sufficiently altered the localized hydrology that the feature now exhibits jurisdictional characteristics. This tributary is performing functions that relate to the biological, chemical, and physical functions of the downstream TNW. The tributary provides breeding grounds for aquatic species and habitat for wildlife in the area. The tributary also helps to filter pollutants from run-off associated with offsite commercial development before flowing to the downstream perennial RPW and TNW. This tributary performs flow maintenance functions by storing water during times of heavy rain and the wetter months.

Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the TNW, it has been determined there is a significant nexus between the relevant reach of the tributary to the downstream TNW.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form documents one jurisdictional seasonal tributary. Seasonal RPWs are jurisdictional according to guidance provided, however, the significant nexus findings for the record are included as required by Rapanos Guidance. Therefore, the seasonal RPW documented is jurisdictional under the Clean Water Act and a water of the U.S.

Additional this form documents several features that were potential waters, but were found to be not jurisdictional. This includes 2 upland dug stormwater detention ponds and an area mapped as a wetland, but did not have the wetland characteristics.
