C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is a 9.5 acre partially developed site located directly adjacent to Carolina Forest Boulevard. Onsite by review of aerial photos are six (6) buildings with an improved access road and associated parking areas. In addition, the site is partially comprised of undisturbed forested area located directly adjacent to Carolina Forest Boulevard. Finally, onsite is an upland excavated non-jurisdictional pond. The submitted data forms dated June 17, 2019, document hydrophytic vegetation; however, document the absence of hydric soils and hydrology. A review of the submitted site photos taken June 17, 2019, depict sandy soils with more than 30% uncoated sand grains in the upper 6 inches of soil and the absence of hydrology by depicting no saturation and no oxidation around live roots. Submitted data forms document no indicators of hydrology with the exception of one secondary indicator, the FAC-Neutral Test. Soil samplings submitted on the data forms indicate more than 30% uncoated sand grains in a sandy texture soil; therefore, not meeting any hydric soil indicators. By review of available desktop resources and the information provided by S&ME in the Jurisdictional Determination submittal dated June 19, 2019, the site has been determined to be comprised entirely of uplands.
