The ditch appeared to be excavated from uplands, was dry at the time of the site visit and displayed no evidence of flow. Wetland B is not contiguous or directly abutting an (a)(1) – (a)(3) water. In addition, it is not an (a)(4) adjacent wetland. Therefore, it is an excluded water pursuant to (b)(1).
Non-JD Wetland A	7.7 acres	(b)(1) Non-adjacent wetland	Wetland A is a closed polygon and it surrounded by uplands. It is approximately 50 feet from an offsite, roadside ditch located along Vance Road (Route 10). The roadside ditch appeared to be (b)(5) ditch. The ditch appeared to be excavated from uplands, was dry at the time of the site visit and displayed no evidence of flow. Wetland A is not contiguous or directly abutting an (a)(1) – (a)(3) water. In addition, it is not an (a)(4) adjacent wetland. Therefore, it is an excluded water pursuant to (b)(1).
