- B. Typical year assessment(s):** Antecedent Precipitation Tool (APT) data for typical year determination was calculated for the date the site was visited by the Corps (6/24/2020). This date was considered to be Normal conditions.
- C. Additional comments to support AJD:** The USGS webservice topo map Irmo Quad depicted a blue polygon with no adjacency to any other potential water, and the USFWS National Wetland Inventory depicted a polygon codified as PEM1Fx, this modifier is used to identify wetland basins or channels that were excavated by humans. This project includes one non-jurisdictional upland dug pond that was constructed wholly in uplands making it an excluded water. Precipitation data generated for this date indicated the site visit was conducted within normal conditions.
