- B. Typical year assessment(s): Antecedent Precipitation Tool (APT) data for typical year determination was calculated based on field collection data denoted on the originally included wetland delineation data forms (October 22, 2020). Output from the APT indicated "Wetter than Normal Conditions" at the time of data collection by the agent (Southern Palmetto Environmental) with a value of 15. ATP outputs with a condition value greater than 14 indicate "wetter than normal" conditions, "normal" conditions range from 10-14, and values less than 10 are considered "drier than normal". For this assessment, the APT tool pulled data from 10 weather stations within an approximate radius of miles. Results of the APT indicate the site visit was conducted outside of conditions considered by the Corps to be within a "typical year". However, even under the elevated hydrologic conditions indicated by the APT output, Excluded Water 1-7 onsite remain non-jurisdictional, with a single jurisdictional wetland.
- **C.** Additional comments to support AJD: The area in review contains 42.82 acres and includes seven excluded waters and a single jurisdictional wetland. Excluded Water #1 is a 6.21-acre wetland that lacks the criteria for wetland adjacency.
