B. Typical year assessment(s): Antecedent Precipitation Tool (APT) data for typical year determination was calculated based on field collection data denoted on the originally included wetland delineation data forms (January 7, 2021). Output from the APT indicated "wetter than normal" conditions at the time of data collection by the agent (Southern Palmetto Environmental) with a value of 17. ATP outputs with a condition value greater than 14 indicate "wetter than normal" conditions, "normal"

conditions range from 10-14, and values less than 10 are considered "drier than normal". For this assessment, the APT tool pulled data from 10 weather stations within an approximate radius of 10 miles. Results of the APT indicate the site visit was conducted under conditions considered by the Corps to be outside a "typical year". However, APT results being wetter than normal conditions in combination with the geographic positioning of waters and uplands onsite are such that it would not change the jurisdictional status of those features.

C. Additional comments to support AJD: This form addresses 81.91 acres in Myrtle Beach, SC. The site is made up of an abandoned former golf course. The project boundary is surround on all sides by residential development. Present on site is one Jurisdiction feature. JD Pond 1 is an (a)(3) impoundment that contributes surface water to the Waccamaw River, an (a)(1) water. The remaining waters on site are (b)(8) excluded waters.
