updated July 17, 2020, depicts palustrine wetlands within the southern half of the project site. However Google Street View and LiDAR data shows that the site is an upland lot with building pad, existing house and parking, that does not contain any potential aquatic resources.

X USGS topographic maps: USGS Topographic Maps / 7.5 Minute Index / Kingstree Quad / 1:24000 depicts a cleared upland site with wetland symbology located offsite which is in agreement with the LiDAR.

- C. Additional comments to support AJD: This 0.10-acre site can be described as an existing single-family home site. Utilizing remote data resources, including LiDAR and site photographs, this site was determined to contain no potential aquatic resources. LiDAR does not depict any low-lying areas that would potentially indicate waters of the United States and the palustrine area depicted on NWIs can be seen containing an upland berm. Google Street images show an existing mobile home, yard and parking area.
