C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was conducted for this determination. The entire site was determined to be comprised of uplands. The site is mapped as uplands on NWI maps, except for a tributary depicted along the western property boundary. However, this feature was determined to be a non-jurisdictional ditch. Soil survey information depicts the entire site as a Eulonia soil (non-hydric). There are three (3) perimeter ditches along the property boundaries (one is depicted on NWI maps) and one (1) interior ditch on the property. However, these ditches were excavated entirely out of uplands and drain only uplands. These ditches were determined to be non-jurisdictional.
