- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **One non-jurisdictional isolated wetland is located on the east side of the subject property. Isolated Non-Jurisdictional Wetland 1 is a 0.13 acre depressional wetland entirely surrounded by uplands. A berm separates Wetland 1 from a roadside ditch. There was no apparent surface or shallow subsurface hydrologic connection, no apparent connection to interstate or foreign commerce and no apparent evidence of ecological interconnectivity between this isolated wetland and waters of the U.S. Therefore this wetland was determined to be non-jurisdictional and not regulated by Section 404 of the Clean Water Act.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
