Explain: The 7.32 acre project area contains one 0.17 acre isolated herbaceous wetland. The topo, soils, and NWI maps do not show any indications of aquatic features at the isolated wetland location. The area is an upland residential area.

The tract appears to have historically been the site of a school. The nearest waterbody is an offsite, unnamed tributary to Belton Branch, approximately 900 feet from the isolated wetland. Between the reviewed wetland and the property boundary is upland forest and upland grassed area. The forested wetland showed no evidence of physical, chemical, or biological connectivity to waters of the U.S., including any apparent surface or shallow subsurface hydrologic connection. There was also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. On this basis, this office has determined that this wetland is isolated from waters of the U.S. and is not within the jurisdiction of the Clean Water Act.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the Rapanos Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
