Linear Conveyance runs along the western corner of the project area and connects to the stormwater pond. This linear feature is heavily vegetated in portions along the property. The sloped banks on either side of the conveyance and the straight channel are indicative of a dug channel for wet weather conveyance. Additionally, the feature does not display the characteristics of a tributary such as high sinuosity and clear bed and bank. This feature is surrounded by uplands on-site and appear dug in uplands. The stormwater pond (project number 1325) is an upland dug stormwater pond for the purposes of storing stormwater from an adjacent neighborhood and non-jurisdictional drainage ditches. These features are therefore non-jurisdictional and not subject to regulation under section 404 of the Clean Water Act.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
