This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

In addition, hydrologic indicators observed were: Leaves and trash within the channel being continuously washed downstream, water flowing after 48 hours of a rain fall event and within the growing season, wrack lines consisting of organic debris and trash, and an even distribution of substrates in the stream channel. Additional review of available resources indicates that the tributary has a flow regime of perennial. Topographic maps indicate that the tributary has a flow regime of at least perennial. Topographic map depicts a solid blue line for the majority of the reach which represents a tributary with perennial flow. Aerial photos depict a signature of a linear open water body. In addition, a previous JD –SAC 2008-00959-3JC letter dated 09/19/2008 and SAC-2015-00147-JH letter dated 02/11/2015 determined the tributary to be an RPW with perennial flow.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 12.25 acres. Located on site is a jurisdictional perennial RPW totaling 566 linear feet. Also present is a non-jurisdictional upland dug pond. The remaining portion of the project area has been determined be uplands. USGS topographic survey information depicts a forested upland area. A blue line feature is present on site. Soil survey information depicts the project area as Leon and Pocomoke, both listed on the National Hydric Soil List. Horry NWI depicts the project area as uplands (U14, U42P) and forest wetlands (PFO4B), however; these areas lacked the three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual .
