Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The features documented on this form include two wetlands that were evaluated as potentially jurisdictional pursuant to Section 404 of the Clean Water Act (CWA). The site visit identified a 0.23-acre wetland area and a 0.13-acre wetland area on the 15.5-acre property that are not subject to the CWA. They are characterized as palustrine, forested, isolated wetlands. Both wetlands are identified as Wetland A due to the fact they are separated by a manmade dirt road. Therefore, for the purpose of this evaluation, the two wetlands are being considered the same. The subject property is undeveloped and has residential development on the neighboring properties to the west and south. It should also be noted that Wetland A does extend offsite to the neighboring, undeveloped property to the north.

The features exhibit no apparent connection/conveyance to waters of the United States; to include no physical, chemical, or biological connections, and no apparent shallow subsurface flow connections to other waters. In addition, the features do not exhibit any apparent ecological interconnectivity with other water features, including any waters of the United States, and there is no apparent connection to interstate or foreign commerce. Furthermore, even though Wetland A extends offsite to a neighboring property, it still does not have any identifiable connectivity with other waters.

On the basis of the aforementioned information, this office has determined that the above-referenced Wetland A documented on this form is considered isolated and not subject to the jurisdiction under the CWA.

C. SIGNIFICANT NEXUS DETERMINATION

Furthermore, the wetlands do not exhibit any apparent ecological interconnectivity with other water features, including any waters of the United States. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Based on a site inspection, soil survey data, aerial/site photos, quad/topo sheets, lidar data, and wetland determination forms, there is a jurisdictional 3.14-acre palustrine, forested wetland (Wetland B) within the project boundary. Wetland B is part of a larger wetland system that extends offsite and directly abuts Simmons Creek (a TNW). Simmons Creek is tributary to the Stono River and is a Section 10 water subject to the ebb and flow of the tide. Water from the tributary can flow directly into the wetlands and vice versa. Therefore, Wetland B is within the jurisdiction of the Clean Water Act.

The jurisdictional status of Wetland A is documented on Form 1 of 2.
