dug farm pond is located in the center of the site and does not have any hydrological connection to any other aquatic resource. There were no drainage structures except for a low spot where water would likely flow in the event of heavy precipitation. The Corps investigated this area where water would potentially flow and no evidence of relatively permenant flow or wetland characteristics were observed (Data Point #2). The non-jurisdictional drainage feature is located at the northeast portion of the site and is angled northwest to southeast. This appears to collect storm water from offsite but does not hold enough water to be considered a wetland and does not show signs of relativly permenant flow. Both the upland dug pond and non-jurisdictional drainage feature are located in Herndon soil (non-hydric) The pond shows up on the USGS topography map but with no connection to any aquatic resources. On the NWI map, the pond is identifed as being connected to a small segment of R5UBH and then into R4SBC but these riverine features were not observed in the field. The non-jurisdictional drainage feature shows a small segement of a dashed blue line that connects off-site to another dashed line but field observations do not support this. Based on submitted, available, and collected information, including aerial imagery and an on-site visit on February 22, 2017, these features are non-jurisdicational and are not waters of the United States.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ## C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site contains an upland dug pond and a non-jurisdictional ditch which were examined on-site on February 22, 2017 due to their potential to be jurisdictional. After a site visit and additional data review, both features were found to be non-jurisdictional. These features are not subject to the Corps' authorities pursuant to Clean Water Act or Rivers and Harbors Act.
