C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Limits of jurisdiction of wetlands were established by 1987 Delineation Manual. The onsite wetlands comprises a portion of a natural drainage basin of the Waccamaw River. Wetland system continues offsite and eventually abutts the HTL / MHW of the Waccamaw River. Located within the wetland boundary is a mand made ditch that did not include tributary indicators (see photo #4 in the administrative record). Since this features falls completely within the boundary of the wetland, it is considered a intergal part of the wetland and was not seperated out as an additional jurisdictional feature.

A non-jusrisdictional swale located north of an adjacent to Hutson Road is situated near the border of the project boundary. This features conveys surface water from runoff / storm events only. (See photo #3 submitted with the original request in the administrative record)
