C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 10.8 aces in Myrtle Beach, SC. Present on site are 0.053 acres of wetlands and 0.02 acres of a PRWP. The project area is also bisected by several upland dug ditches. These ditches do no provide a hydrologic connection to any other aquatic feature and were dug out of uplands. The remainder of the site was determined to be uplands. USGS topographic survey information depicts a cleared forested area. Soil survey information shows the project area is comprised of the partially hydric soil Yauhannah. NWI maps show a signature of wetlands in the marked wetland areas and the remainder is mapped uplands.
