Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A portion of the project area is mapped as a partially drained/ditched wetlands (PFO4Ad)). However, these areas lacked the three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual. The parameters specifically not present were the hydric soil parameter and hydrology prarameter. Data forms submitted by the Brigman Company revealed the soil had more than 30 percent uncoated sand grains in the upper surface therefore not meeting any hydric soil indicators and hydrological indicators were not observed. Also present on site is an upland dug pond that provides no hydrologic connection to any other aquatic resource.



# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

USGS topographic survey information depicts a forested area that is void of wetland symbols. NWI maps depict the project area as upland planted pine (U42P) and drained/ditched forested wetlands (PFO4Ad) however; these areas lacked the three parameters which define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual. The parameters specifically not present were the hydric soil parameter and hydrology parameter. Data forms submitted by the Brigman Company revealed the soil had more than 30 percent uncoated sand grains in the upper surface therefore not meeting any hydric soil indicators and hydrological indicators were not observed. The project area is comprised of the hydric soil Leon. Based on a combination of the above listed resources and previous adjacent JD determinations the project area was determined to be void of aquatic resources.
