Explain: **The project area contains twenty one (Wetlands #2-23) isolated, non-jurisdictional freshwater wetlands with no connection to any waters of the United States located either onsite or offsite. Wetlands located within the project area meet the parameters that define a wetland outlined in the 1987 Wetland Delineation Manual; however, these wetlands were determined not to be adjacent to any waters of the United States. Additionally, there are two upland excavated non-jurisdictional linear features laterally bisecting a portion of the project area. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of approximately 150.815 acres of freshwater wetlands. Forested freshwater wetlands #2-23 (20.392 acres total) located within the project area have been determined to be completely surrounded by uplands and no surface or shallow subsurface connection to any water of the U.S. (WOUS) was evident during the site visit or could be found after review of aerial photography, soil survey information, NWI maps, LIDAR maps and topographic maps. Wetlands #2-23 are depressional wetlands that exhibited hydric soils, hydrophitic vegetation, and sufficient indicators of hydrology to satisfy the criteria set forth in the 1987 Wetland Delineation Manual. However, all water located within or draining toward this wetland has no discernible or traceable outfall or connection to any waters of the United States. Additionally, the wetland system in review was found to be surrounded completely by forested uplands, and upland development (residential subdivisions and Highways) further disrupting possible connections to any WOUS. Chemically, the wetlands do not affect any WOUS in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of the wetlands and their relation to other WOUS is such that water in this wetland is retained and eventually percolates through the soil to groundwater only, to an unknown depth, providing little if any stromwater attenuation. Biologically, these wetlands are not essential in providing organic carbons in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical, physical or biological connection, wetlands #2-23 have been determined to be isolated, non-jurisdictional. Additionally, there are several upland excavated non-jurisdictional ponds that have been determined not to be an impoundment of any waters of the US. A site visit was conducted on February 20, 2015 during below normal level of rainfall conditions. For the time period of January 16 – 22, 2015 the North Myrtle Beach area weather station recorded a -1.2" departure from average.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries established by the 1987 wetland delineation manual. The project area contains a single jurisdictional wetland which is designated W-1. Wetland W-1 displayed the appropriate wetland hydrology, hydrophitic vegetation, and hydric soils to meet the three required wetland parameters. Additionally, this wetland is part of a wetland complex that continues offsite, uninterrupted, and makes up the headwaters of Socastee Swamp. Tributary was determined to be an RPW with perennial flow by review of aerial photos and topographic map. aerial photos depict a signature of a defined channel discharging into a tributary that discharges directly into the Atlantic Intracoastal Waterway (AIWW), Topographic maps depict a named (Socastee Swamp) with solid blue line, the symbol that typically represents a tributary with a flow regime of perennial .

A site visit was conducted on February 20, 2015 during below normal level of rainfall conditions. For the time period of July 7 –13, 2014 the North Myrtle Beach area weather station recorded a -1.2" departure from average.

This site as assessed on 2 basis forms. Isolated features (wetlands #2-23) are documented on form 1 of 2 of this determination.
