Three of these linear features were previously determined to be non-jurisdictional (SAC 2011-00528-4E, letter dated November 8, 2011). The center linear feature that intersects the property from the southwest corner to the northeast corner was previously determined to be a seasonal RPW. During the site visit, the center linear feature was observed in several locations on site. Large vegetated berms were observed on either side of the feature which further supports evidence that this feature is man-made. Photographs taken by the Corps on June 30, 2011, September 8, 2011, and May 26, 2015, depict this feature as not having any water present. Because this man-made feature does not support flow except after major storm events, it was determined to be a non-jurisdictional ditch as well

According to the NWIs, the northern portion of the site is mapped as wetlands (PSS1A). A data point taken by the agent in this area found a presence of hydrophytic vegetation and hydric soils but no indicators of hydrology. Because of the presence of multiple non-jurisdictional ditches on site that effectively drained this area, the presence of hydrology cannot be assumed even though the site visit occurred during the dry season. Therefore, this site was determined to be void of wetlands or other waters of the US.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Three of these linear features were previously determined to be non-jurisdictional (SAC 2011-00528-4E, letter dated November 8, 2011). The center linear feature that intersects the property from the southwest corner to the northeast corner was previously determined to be a seasonal RPW. During the site visit, the center linear feature was observed in several locations on site. Large vegetated berms were observed on either side of the feature which further supports evidence that this feature is man-made. Photographs taken by the Corps on June 30, 2011, September 8, 2011, and May 26, 2015, depict this feature as not having any water present. Because this man-made feature does not support flow except after major storm events, it was determined to be a non-jurisdictional ditch as well

According to the NWIs, the northern portion of the site is mapped as wetlands (PSS1A). A data point taken by the agent in this area found a presence of hydrophytic vegetation and hydric soils but no indicators of hydrology. Because of the presence of multiple non-jurisdictional ditches on site that effectively drained this area, the presence of hydrology cannot be assumed even though the site visit occurred during the dry season. Therefore, this site was determined to be void of wetlands or other waters of the US.
