- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are two wetlands located within the project review area. Wetland #1 is approximately 1 acre in size and extends offsite. No ditches or other features were observed connecting to or from the wetland on the subject project review area. In addition, some of the offsite portion of the wetland boundary of wetland #1 was observed from the subject project review area and no ditches or other features were observed coming out of wetland #1. The adjacent properties were inaccessible and so it is not known if additional wetlands or other possible hydrologic connections may be present. A review of aerial photographs, NWI mapping, and soil survey information does not indicate that wetlands or other features are present on the adjacent properties that may provide a hydrologic connection for wetland #1. Additional site inspections were made at publicly accessible points near the subject project review area but no other wetlands, waters, or features such as ditches and swales were observed to potentially provide a hydrologic connection for wetland #1. On the subject project review area and the offsite area that was observed, no evidence of discrete surface hydrologic connection through the uplands to other waters of the U.S. was observed. There was also no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. Based on all of this information, wetland #1 was determined to be isolated and non-jurisdictional, therefore not regulated by Section 404 of the CWA.**

The second wetland located within the project review area is approximately 0.7 acre in size. The entire wetland is located within the project review area. It is slightly lower in elevation than the surrounding uplands, has no ditches or other features coming out of it, is surrounded completely by uplands, and there is no evidence of discrete surface hydrologic connection through the uplands to other waters of the U.S. There was also no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. For these reasons, wetland #2 was determined to be isolated and non-jurisdictional, therefore not regulated by Section 404 of the CWA.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is

the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
