jurisdictional. The wetland is approximately 0.163 acres. The wetland is surrounded by uplands and is positioned lower in the landscape than the adjacent uplands and had no linear features coming out of the wetland, and no evidence of discrete surface hydrologic connection through the uplands to other waters of the U.S. was observed. There was also no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland was determined to be isolated and non-jurisdictionL, therefore not regulated by Section 404 of the CWA.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This is a 2.808 acre site with 0.163 acres of non-jurisdictional wetlands. There is no discernible connection between the wetlands and any other waters of the U.S; therefore the project site is not subject to regulation under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act.
