C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area consist 14.96 acres of uplands with an onsite tributary subject to the jurisdiction under Section 404 Clean Water Act. A Site visit not performed due to the previous JDs performed in 2007 & 2012 both determining the site to consist of uplands as well as the mapped soil type of Leon. Onsite tributary has been determined to be a jurisdictional feature by review of available desktop resources as well as previous JDs performed both up and downstream of the project area. Tributary flows directly to Cross S swamp which flows directly to Socastee S swamp which is considered a YNW. .
