- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are three (3) wetlands, Wetland A (0.276 ac), Wetland B (0.911 ac) and Wetland D (3.536 ac), located within the project review area that were determined to be isolated and non-jurisdictional. The wetlands are surrounded by uplands and are positioned lower in the landscape than the surrounding uplands. No ditches, swales or evidence of discrete flow through uplands that would potentially provide a hydrologic connection from the wetlands to Waters of the U.S. are present. In addition to not having a surface hydrologic connection, the wetlands have no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to Waters of the U.S. The wetlands also have no apparent ecological interconnection to Waters of the U.S. For these reasons, Wetlands A, B and D were determined to be isolated and non-jurisdictional; therefore, they are not regulated by Section 404 of the CWA. The remaining wetlands and features present within the project review area are discussed on Form 2 of 2.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
