pond is located within Cecil Sandy Loam soil classified by SSURGO data. There is no draw or blue line of any type in the vicinity of the upland dug pond on the USGWS topography map. NWI data does not show any feature in this area either. From examining aerial photographs it appears this pond was dug sometime between November 2013 and 2015. Multiple photographs provided by the consultant shows that this pond is small and experiences significant changes in water level based on the lack of vegetation around the open water areas. Based on submitted, available, and collected information, this feature is non-jurisdictional and is not a water of the United States.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
