Explain: The 2.48 acre project area contains 1.58 acre of forested freshwater wetland. In addition to utilizing remote resource

tools (to include USGS Topographic map, LIDAR, and historic aerial photographs found on Google Earth Pro), a field inspection was completed on May 16, 2018 to verify the boundary of the wetland and the wetland's jurisdictional status. The wetland sits in a depression within the landscape and is surrounded by uplands. The wetland has no apparent physical, chemical or biological connection to waters of the U.S., and has no apparent surface or shallow subsurface hydrologic connections to waters of the U.S. The wetland also has no connection to interstate or foreign commerce. The surrounding uplands consists of urban development to include roads, commercial businesses, and residential developments. The recent urban development has physically separated the wetland from the other waters in the watershed. The waters located on the adjacent properties to the southwest of this 2.48 acre project area were determined to be isolated and non-jurisdictional in 2002 and 2003 (SAC-80-2002-0025 and SAC-87-2003-1418(B). In addition, this 2.48 acre project area had an AJD verification in 2005 which determined the same 1.58 acre of wetland to be isolated and non-jurisdictional (SAC-87-2005-0790-2). Therefore, the 1.58 acre wetland within the 2.48 acre project area was determined to be isolated and non-jurisdictional, and not subject to regulation under Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
