B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: The topographical and NWI maps shows the presence of what use to be a water detention pond used for firefighting. However, the photos and data provided by the agent from their onsite inspection demonstrate the absence of water anywhere on property. This office agrees with the conclusions of the submitted information. The project area consists entirely of uplands.
