

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B.** ADDITIONAL COMMENTS TO SUPPORT JD: The project area contains 4.98 acres of which consist entirely of uplands. A site visit was performed after approximately 2 inches of rainfall within a 24 hour period. Areas visited did not contain the hydrology parameter and therefore did not meet the three parameters that define a wetland. Within the potential wetland areas are several non-jurisdictional ditches that contained about 2 inches of water within the ditches bed. The onsite non-jurisdictional ditches did not exhibit any flow characteristics an RPW.
